WHEREAS, due to the increased need of teacher lead advisors, it is agreed upon the positions of grade 6, grade 7, Math Advisory-Elementary and Jacket Leadership Advisors should be added to the Appendix B (Extracurricular Salary Schedule) for the 23-24 and 24-25 school years and Student Council shall be named Student Advisory, Right to Read Week Coordinator shall be named Literacy Advisory-Elementary, Service Learning to be named
