

**New Riegel Local Board of Education  
Regular Meeting Minutes  
August 14, 2023**

Meeting was called to order by President Jeff Hohman.

The following members were present: Rodney Biggert, Angel Bodart, Jeff Hohman, Darin Nye and Jaclyn Schalk.

Superintendent David Rombach reported on the District Accomplishments from the 2022-23 school year which included Staff training and additional safety and security measures that were accomplished thru the use of Grants. He also reviewed the different Grants that the school received and utilized last school year. Mr. Rombach was also pleased to review the District Goals for the 2023-24 school year including refinement of our Career Based Instruction, our Social Emotional Programming and our Literacy Based Instruction.

Families will not only have a chance to get acquainted with the student's new classroom and teacher but will also get to enjoy some additional fun activities on the playground. Mrs. Barrows also reviewed goals for the 2023-24 school year including implementing a Phonics Curriculum and new SAIL Initiatives.

Middle School/High School Principal Valarie Zeno reported that a new student/family open house was held on August 14<sup>th</sup> to help new families get acquainted with the school. Mrs. Zeno also reviewed goals for the 2023-24 school year including implementing a new junior leadership program in the middle school and beginning to develop career readiness opportunities for high school students.
