

**New Riegel Local Board of Education
Regular Meeting Minutes
November 13, 2023**

Meeting was called to order by President Jeff Hohman.

Superintendent David Rombach reported that the school received two sealed bids for the chiller and Wadsworth Solutions was awarded the contract to replace the chiller for the K-12 building.
