

**New Riegel Local Board of Education
Regular Meeting Minutes
March 11, 2024**

Meeting was called to order by President Jaclyn Schalk.

The following members were present: Rodney Biggert, Jeff Hohman, Darin Nye, Jaclyn Schalk and Darrell Tiell.

Superintendent David Rombach updated the Board on several facility upgrades that are currently happening within the school including upcoming concrete repairs, the parking lots being resealed and a new access path around the baseball and softball fields being installed. In addition, Mr. Rombach stated to the board that Kindergarten screening will be open to the general public on Friday, April 26, 2024 with pre-registration encouraged.

Treasurer Brad Radison reported to the Board that we have received our annual payment for the rights to our air space. In addition, the Board accepted the amounts and rates that were determined by the county budget commission for the school budget.

Elementary Principal Jamie Barrows reported on many different activities happening around the school including K-5 S.A.I.L. meeting focused on their theme of Wonderful World, Wonderful Life. Mrs. Barrows also informed the Board about the upcoming staff professional development day being centered around strategies to supports students in the classroom.

Middle School/High School Principal Valerie Zeno reported to the Board that the ACT will be administered on March 14th. Mrs. Zeno also informed the board that the upcoming high school staff development day will be focused on course syllabi for the 2024-2025 school year, state testing preparation and grading procedure review.
