

**New Riegel Local Board of Education
Regular Meeting Minutes
March 13, 2023**

Meeting was called to order by President Jeff Hohman.

The following members were present: Rodney Biggert, Angel Bodart, Jeff Hohman, Darin Nye and Jaclyn Schalk.

Treasurer Brad Radison reported to the Board that we will be receiving our Real Estate Tax settlement this month. In addition, the Board accepted the amounts and rates that were determined by the county budget commission for the school budget.
