

**New Riegel Local Board of Education  
Regular Meeting Minutes  
July 10, 2023**

Meeting was called to order by President Jeff Hohman.

Treasurer Brad Radison presented to the Board fiscal year-end financial information. The general fund ended with revenue over expenditures of \$22,145. Total general fund revenue decreased by 0.9% and expenditures increased by 4.8% over the prior fiscal year.

Superintendent David Rombach reported on the progress of several facility and maintenance items that are in different stages of completion around the district. Mr. Rombach also spoke about the revised language on several of the school policies that the Board will vote on in August.
