Organizational Meeting Minutes
January 8, 2024**

Treasurer Brad Radison conducted a budget hearing and review for the budget period July 1, 2024 through June 30, 2025.

President Pro-Tem Dr. Jaclyn Schalk conducted the Organizational Meeting until election of the Board President.

#6312-24 Rodney Biggert moved to appoint Mr. Darrell Tiell to fill the vacant position on the New Riegel Board of Education until December 31, 2024.

Motion seconded by Jeff Hohman. Vote as follows: Biggert-yes, Hohman-yes, Nye-yes, Schalk-yes.

Treasurer Brad Radison administered the oath of office to newly appointed board member Darrell Tiell.

The following members were present: Rodney Biggert, Jeff Hohman, Darin Nye, Jaclyn Schalk and Darrell Tiell.

#6313-24 Jeff Hohman moved to nominate Jaclyn Schalk for President.

Motion seconded by Rodney Biggert.

#6314-24 Jeff Hohman moved to close nominations for President.

Motion seconded by Rodney Biggert. Vote as follows: Hohman-yes, Biggert-yes, Nye-yes, Schalk-abstain, Tiell-yes.

Vote for President: Biggert-for Jaclyn Schalk, Hohman-for Jaclyn Schalk, Nye-for Jaclyn Schalk, Schalk-abstain, Tiell-for Jaclyn Schalk. Jaclyn Schalk elected Board President.

Vote for Vice-President: Biggert-for Darin Nye, Hohman-for Darin Nye, Nye-abstain, Schalk-for Darin Nye, Darrell Tiell-for Darin Nye. Darin Nye elected Board Vice-President.

Treasurer Brad Radison administered oaths of Office of President and Vice President.

#6319-24 Rodney Biggert moved to name Scott, Scriven, Wahoff LLP of Columbus, Ohio as Board of Education legal counsel for 2024.

#6320-24 Jeff Hohman moved to authorize the Treasurer to request advances from the County Auditor as funds become available and to invest all interim funds at the highest available rate of interest.

Motion seconded by Darrell Tiell. Vote as follows: Hohman-yes, Tiell-yes, Biggert-yes, Nye-yes, Schalk-yes.

#6321-24 Darin Nye moved to declare the Superintendent as chief purchasing agent for all goods and services and to authorize payment by the Treasurer of all invoices for goods and services deemed acceptable by the Superintendent for 2023.

Motion seconded by Rodney Biggert. Vote as follows: Nye-yes, Biggert-yes, Hohman-yes, Schalk-yes, Tiell-yes.

#6322-24 Rodney Biggert moved to authorize the Superintendent and Treasurer to enter into and/or accept/participate in Federal, State or Local Grants or agreements and authorize the Treasurer to appropriate funds for the grant awarded.

Motion seconded by Darin Nye. Vote as follows: Biggert-yes, Nye-yes, Hohman-yes, Schalk-yes, Tiell-yes.

#6323-24 Jeff Hohman moved to approve membership in the Ohio School Boards Association for calendar year 2024 at a cost of \$4,537.00 inclusive of publications.

Motion seconded by Darrell Tiell. Vote as follows: Hohman-yes, Tiell-yes, Biggert-yes, Nye-yes, Schalk-yes.

#6324-24 Darin Nye moved to designate The Advertiser Tribune as the official newspaper of the district.

Motion seconded by Rodney Biggert. Vote as follows: Nye-yes, Biggert-yes, Hohman-no, Schalk-yes, Tiell-yes.

#6325-24 Rodney Biggert moved to authorize the Treasurer to file requests for amendments of the Certificate of Estimated Resources with the Seneca County Auditor as information becomes available to the Treasurer to warrant such a filing.

Motion seconded by Darrell Tiell. Vote as follows: Biggert-yes, Tiell-yes, Hohman-yes, Nye-yes, Schalk-yes.

#6326-24 Darrell Tiell moved to authorize the Superintendent to employ such temporary personnel as needed in emergency situations. Such employment will be presented to the Board of Education for approval at the next regular meeting.

Motion seconded by Rodney Biggert. Vote as follows: Tiell-yes, Biggert-yes, Hohman-yes, Nye-yes, Schalk-yes.

#6327-24 Jeff Hohman moved to approve expending public funds to purchase coffee, meals, refreshments or other amenities for professional development/meetings, staff recognition and service awards, and items for bereavement as a means to promote public health, safety, morals, general welfare, security, prosperity, and contentment of all participants.

Motion seconded by Rodney Biggert. Vote as follows: Hohman-yes, Biggert-yes, Nye-yes, Schalk-yes, Tiell-yes.

#6328-24 Rodney Biggert moved to appoint Brad Radison as the Public Records Designee for the Board and David Rombach as the alternate.
