

**New Riegel Local Board of Education

In old business the Board discussed the possibility of raising the required minimum GPA for extracurricular activity participation. Discussion was held on how we can help students at risk of losing their eligibility.

In new business Superintendent Rombach presented a Powerpoint presentation highlighting accomplishments from the past school year and also district future short and long term goals.

Also in new business Jeff Hohman commented he was approached in favor of the school not requiring Covid vaccines for its staff and students. Mr. Rombach commented there are no plans to require Covid vaccines.

Beth Kummerer advised the Board to learn more about Critical Race Theory as the subject may be brought to the BOE in the future.
