

**New Riegel Local Board of Education
Regular Meeting Minutes
August 10, 2020**

Meeting was called to order by President Jaclyn Schalk

The following members were present: Rodney Biggert, Angel Bodart, Jeff Hohman, Beth Kummerer and Jaclyn Schalk.

Treasurer Jane Schalk reported to the Board of Education income tax second quarter collections were down 21.5% from last year's collections, same period.

5-12 Principal Justin Johnson reported on school year preparations, staff meetings, safety protocols and a virtual open house.

Superintendent David Rombach reported on the district's restart plan which is posted on the district's website. The plan includes the logistics of educational and safety protocols for returning to the building. He also reported 26 students have chosen distance learning through the Blue Jacket Academy.
