

**New Riegel Local Board of Education  
Regular Meeting Minutes  
October 11, 2021**

Meeting was called to order by President Rodney Biggert.

The following members were present: Rodney Biggert, Angel Bodart, Jeff Hohman, Beth Kummerer and Jaclyn Schalk.

Treasurer Jane Schalk reported Anthem medical insurance rates will increase by 6%. Employees recently completed online health surveys which will be sent to other carriers to receive other medical insurance rate quotes.
