Organizational Meeting Minutes
January 10, 2022**

Treasurer Jane Schalk conducted a budget hearing and review for the budget period July 1, 2022 through June 30, 2023.

President Pro-Tem Jaclyn Schalk conducted the Organizational Meeting until election of the Board President.

Treasurer Jane Schalk administered oaths of office to newly elected board members Jeff Hohman and Jaclyn Schalk.
